a. Director's Report – Carroll

- Carol Gyger, Systems Administration Manager is at the Innovator Users Group (IUG) conference in Minneapolis where she will be receiving the Beacon Award tomorrow. This is awarded to one person for outstanding service to the IUG community each year.
- She and Jeff Barnes have been communicating with realtor Peter Kast regarding the lease/purchase of Webster House Administration Center building/property. This topic will be on the board agenda next month.
- As mentioned in the written report, Executive Director Carroll recently attended the Colorado Association of Libraries (CAL) Lobby Day at the capitol. She distributed copies of a document entitled: State Grants to Libraries Act (CRS 24-90-401) and the Poudre River Public Library District for the board's information.

b. Library Trust Update – Gabel

Trustee Gabel reported that she attended the most recent Trust meeting. The group is going through some changes. Several members are unable to continue their membership due to health issues, so an unofficial recruitment for new members is underway. The Trust is looking forward to hearing from this board after its upcoming retreat re: the new Strategic Plan for the District in hopes that something concrete will come out of it that they can put their time, energy and efforts into fundraising for.

c. Friends of the Library Update – *Birks*

Trustee Birks reported that:

- The Friends recently presented a check to Fort Collins READS for \$1,500.
- The group is busy going through their inventory and considering the sale of some specialty items/rare books.
- They are also considering the idea of holding special sales, e.g. only children's books throughout the year.

a. Council Tree Remodel – Draves

Deputy Director Draves gave an update on the remodel project:

- The preconstruction meeting was held on April 2.
- At 9 p.m. tonight, the demolition of the circ desk begins.
- Replacement desks are already in and ready for installation.
- There will be improvements in the children's area this week.
- Overall, the improvements will provide a better flow especially on storytime days.
- The project should be complete mid-May.

b. Strategic Planning Retreat/Preparation – Frey & Carroll

Executive Director Carroll informed the board that a Scope of Services was sent out to two individuals for facilitation services at the retreat. She is waiting for a response and hopes to make a recommendation soon.

To prepare board members for the work ahead at the retreat, she plans to do much of the legwork; she will organize the trends and best practices for the board. Look for more information to come as the date nears.
