I. CALL TO ORDER

d. 2021 Summer Reading Challenge Presentation – Zachman

Ms. Zachman presented to the board information about the 2021 SRC program currently underway. Registration began June 1 and ends on August 15. To date, there are 200 fewer customers registered than on this date in 2020. A video about the program was created by the Communications Department and features several staff members promoting it. Ms. Zachman offered to share the link to the video in case anyone would like to share it out. The board thanked Ms. Zachman and all the staff working hard to provide many options for customers to enjoy this summer.

VI. UNFINISHED BUSINESS

a. In-person Board of Trustee Meetings - Colby

President Colby asked Executive Director Slivken for his thoughts on resuming inperson board meetings. Mr. Slivken said that with the recent relaxation of guidelines related to COVID precautions, that technically going back to in-person can resume as soon as the July board meeting, assuming nothing changes between now and then. He did note that unfortunately, the Community Room at Old Town Library is still serving as a storage area for the tables and chairs and other furniture, and he is unsure at this point of the plans to restore the furniture to its original locations. He indicated he would discuss this with Manager McCluskey and let the board know soon.

VII. NEW BUSINESS

a. United for Libraries Videos – Wise

Trustee Wise suggested that the board participate in the United for Libraries' Short Takes for Trustees which is a series of 10 short videos (8-10 minutes each) that can be shown during Trustee meetings to stimulate discussion about the important role that

Trustees play in the governance of their libraries. Topics in the series explain the basics, such as what it means to be a Trustee, as well as how to set policy, how to evaluate the library director, along with board self-evaluation, and the ethical and parliamentary standards for boards — both governing and advisory.

The board agreed this is a good idea. Trustees Wise and Radman will coordinate the trainings. It was requested that the information be sent to the board members ahead of time, so members have time to review and prepare to discuss.

VIII. ANNOUNCEMENTS

a. Friends of the Library Update - Wise

Trustee Wise reported that:

- The FOL held an additional Grab n Go book sale this past Saturday at Harmony. No numbers are in yet.
- Soon, there will be a self-serve Apple Pay reader installed at Old Town Library for FOL book purchases.

b. Library Trust Update - Radman

Trustee Radman reported that no meeting was held so there is no report.

President Colby announced the Board had been in Executive Session pursuant to §24-6-402(4)(b) and (f), C.R.S., for the Board to receive legal advice from the Library District attorney concerning personnel matters.
