# Executive Director's Report March 2017

### **ADMINISTRATION**

#### **Directing Change**

The PRPLD has been participating in a newly formed group of non-profits called "Directing Change". There are about 20-30 active non-profit organizations who are participating, and for the time being, it is being led by Seth Kelley, who heads Base Camp after school program for the Poudre School District. Seth was on the panel for the Outreach Services presentation at the March board meeting. This initiative has opened up opportunities for the Poudre Public Library District for additional collaborations.

### <u>tif</u>

Both Jeff Barnes and I are members of the TIF (Tax Incremental Financing) Study Group. This group is comprised of County government officials and representatives of the three municipalities currently utilizing tax increment financing (Fort Collins, Loveland, Timnath), plus representatives from the other five municipalities in Larimer County and representatives from selected taxing districts and special districts. The TIF Study group was formed to discuss issues that have arisen regarding the use of tax increment financing, to quantify related economic effects and fiscal impacts on Larimer County, and to seek policies and agreements that balance the interests of the County, other taxing districts, and the participating municipalities. The TIF Study Group acknowledges the positive contributions of public investments provided by tax increment financing to the economic development and vitality of Larimer County's municipalities, and seeks to find solutions to allow for its beneficial use in the future consistent with sustainable funding for Larimer County and the other taxing districts that are highly dependent on property tax for funding. Jeff and I plan a more thorough presentation in the upcoming months.

#### CAL Legislative Day

CAL Legislative Day was on March 14<sup>th</sup> and I had the opportunity to visit the State Capitol and thank legislators for state grants that allow us to offer library programs focusing on early literacy. Unfortunately, there was an important legislative agenda that day, so attendance by legislators was lower than usual. I did get a chance to thank John Kefalas and Joann Ginal for being very supportive of state library funding. They both regularly hold meetings at PRPLD facilities, most recently at Council Tree, where they had an overflow crowd.

#### **Master Facilities Plan**

Dennis Humphries and Dick Waters will be holding a series of meetings with library staff, library board, Library Trust, Library Friends, and various community groups (non-users, users with barriers, Spanish speaking, homeless, and early childhood providers).

#### Metro Directors and Front Range Library Directors/CAL Retreat

I have been regularly attending meetings of the Front Range Library Directors and the Metro Library Directors. Many members have shared their foresight and knowledge regarding libraries in Colorado and this has helped immensely in my transition to Colorado. I regularly communicate with many of them and ask questions and share ideas. The CAL New Library Directors Orientation and Colorado Library Directors retreat will be May 4-5.

#### Security Cameras/Guard Service at Old Town Library

The Old Town security cameras have been installed and staff granted access to archived video have been trained. There are only 3-4 District employees that will have access to archived digital video.

We are in the process of renewing our contract with G4S Security. G4S has been challenged in being able to retain lower level guards. The turnover in guards makes it more challenging to keep the Old Town Library a safe

and secure facility. After reviewing the current contract and recommending changes regarding the expectations of the guards, we are upgrading to better trained guards (many have law enforcement experience). This will cost us more per hour, but with a better trained guard, we are eliminating the times when there are two guards present (20 hours per week). We are confident these changes will lead to a more welcoming environment at the Old Town Library.

#### **Expanding Our Footprint in the Community**

Our Outreach Department has been working with Ken Draves to re-create what we hope will become a robust Homebound Delivery Program. You may have noticed a series of articles in the Coloradoan concerning the elderly and many issues they encounter, particularly loneliness. Our goal is to reach out to people who are isolated and provide them with reading materials and other information to make their lives a little easier. There are several organizations who have expressed an interest in collaborating with us, and we are investigating the best options to move the program forward.

In our 2015 Needs Assessment Survey, 21% of district residents indicated they knew nothing or very little about the Poudre River Public Library District. Additionally, our market share has been dropping....slowly, but dropping nonetheless. What is happening in our region is not unique as many other library systems are experiencing similar declines, but troubling nonetheless. The Library Leadership Team will be exploring options to increase our visibility in the community.

#### **Broadband Technical Group**

I have been appointed to the City of Fort Collins Broadband Technical Group (BTG). On March 30<sup>th</sup>, the group met with officials of an international fiber/ISP company. The intent of this BTG meeting is to give everyone an opportunity to meet and have an open dialogue and learn more about retail broadband options—either run and managed by the City of Fort Collins or through a third party. The City hopes to know by late summer how they will proceed.

#### **Exceptional Achievement in Service-Learning Community Partner Award**

Ludy Rueda, of our Outreach Department, will be the recipient of the *Exceptional Achievement in Service* -*Learning Community Partner Award* for her efforts with the World Languages Story time initiative. This award is presented to a CSU community partner for their commitment to building university-community partnerships that meet community-articulated needs and challenges while supporting the holistic education of the next generation of professionals, leaders, and citizens. The ceremony will take place on April 18, 3-5 p.m. at the Lory Student Center Main Ballroom, Colorado State University.

#### **Gadgets and Things Collection Update**

The *Check-out State Parks: Colorado Library Pass* will continue another year. The *Check Out Colorado State Parks* program is an inter-agency partnership between Colorado Parks and Wildlife, the Colorado Department of Education State Library and local libraries to explore Colorado's state parks. Nearly 300 libraries are participating in the program, including all of Colorado's public libraries, its three military base libraries and publically funded

academic libraries. In the first six months, there were 3,960 checkouts. The state received 720 survey responses (18%). Highlights from the <u>state survey results:</u>

- 94% of respondents agreed that the *Check-out State Parks* changed their view about what libraries have to offer.
- 85% agreed that the experience helped them learn more about nature.



#### New Gadgets Coming Soon:

- <u>Dash Robot</u> Dash provides an intuitive, fun and kid-friendly way to present coding and robotics. Coding and programming are basic literacy skills in the digital age. It helps to empower kids; gives them tools to express themselves; teaches problem solving and logic; and helps them become fluent with technology.
- Acoustimeter RF Meter Model AM-10 Radio Frequency Microwave Detection Meter

"Designed to enable you to make a quick and informed judgement regarding the levels of radio frequency and microwave signals in your environment. Accurately measures the totality of the radiation in the range from 200 MHz to 8000 MHz (8 GHz), which covers the frequencies used by most modern communication systems in our environment. The Acoustimeter was designed using the experience gained from many years of practical RF and microwave measurements."-- Manufacturer.

- <u>Greenwave Receptacle Tester and Dirty Electricity Filter</u> Tests for correct wiring, open ground, reverse polarity, open hot, open neutral, hot on neutral, hot and ground reversed with open hot and ground fault interruption in 3-wire, 120VAC circuits. The Greenwave filter reduces the amount of dirty electricity (a.k.a., electrical noise, line noise, EMI) present on the wiring in buildings.
- <u>Karaoke system</u> This bluetooth karaoke system includes 2 microphones and 300 songs. It can play from all devices and record voice and music mixes.

# **OUTREACH SERVICES**

#### The following programs are a snapshot on our work in the community:

- On March 21, 2017 PRPLD was recognized for its work on furthering cultural awareness through literacy
  programs and the provision of services to diverse families in Fort Collins. A proclamation highlighting Dia del
  Niño and children's day was presented by the Mayor of Fort Collins, Wade Troxell.
- To remove barriers to services and continue to be an open and welcoming place for those who can't come to the branches Ludy Rueda took STREAM to the community during her storytimes. She used Squishy Circuits during storytimes. This activity was a great opportunity to intentionally guide kids in STREAM learning. Many teachers expressed their gratitude for bringing such a great opportunity to students that don't have readily access to innovative technology.



- In accordance to the strategic plan "1.2.1 Remove cultural, social and economic barriers" we began a new series of Citizenship classes in partnership with the Family Center. We have over 20 participants that have been taking advantage of the guidance thought he process of naturalization. Furthermore, free of cost a local immigration lawyer, Kim Medina, provided legal guidance for participants.
- Kathie Young de Herrera provided story times in the community and this month Ozobots were used at different locations. The parents at University Village, who are all spouses of International Doctoral & Post-Doctoral students, all wanted to know where to purchase them.
- Kathie Young de Herrera attended the Public Library Think Tank, in Miami Florida. The focus of the Think Tank
  was on Literacy: Civic Literacy, Early Literacy, Cultural Literacy, Digital Literacy, Adult Literacy, Media & New
  Literacy and Multiple Literacies.
- "4.3 Identify unique spaces for library presence in community" Sylvia Garcia and Erin Kirchoefer were guest presenters at the Fort Collins Senior Advisory Board's March meeting. The Senior Advisory Board is tasked with encouraging networking among the various groups who deal with senior issues and educating the community about those issues. Board members were thrilled to learn about the Library's services and opportunities for life-long learning that may be of special interest to seniors. Our downloadable options and the tutorials on Lynda.com generated excitement.
- Sylvia Garcia and Serena Robb have worked on a proposal to implement changes in the homebound program. The idea is to identify if the model of volunteers delivering materials will allow us to extend services to other homebound patrons. We would like to pilot the project to determine feasibility of a one-on-one model.

# SYSTEMS ADMINISTRATION

The security cameras at Old Town have been installed and tested. The system has an intuitive interface and the image quality is excellent. Thanks to Victor Zuniga for his work on bringing the project to a successful conclusion. City IT assisted with network configuration and offered a solution that reduced the project cost. It was a pleasure to work with the vendor, BW Systems.

Preparations are being made for this year's Summer Reading Program. The website, FAQs, reading certificates, etc. have been updated and the program is currently being tested by staff. The portal will be open to the public on May 22.

The district will move to Office 365 later this year for hosted email. The media mentors have joined the SA team to test the different features available to determine what will be available during the initial rollout. We're working with City IT on the migration details.

## HARMONY LIBRARY HIGHLIGHTS

#### Facilities Planning Process and FRCC/Harmony

Facilities planners Dennis Humphries and Dick Waters are meeting with Harmony staff the first week of April to develop an understanding of Harmony staff members' thoughts about the functionality of the current physical facility and ideas for improvement.

#### **Disaster and Emergency Response Training**

Harmony staff attended the first of three monthly training sessions on the District's new disaster and emergency response plan. The next training will be held in early April.

#### **Improving Cell Service in Harmony**

As reported previously, Harmony library is improving in-library cell service through the installation of cell phone repeaters and antennas in the building and on the roof. The college has worked previously with the same vendor to improve cell service in other campus buildings. We met with the vendor in March and anticipate improved service in the next several weeks.

#### Harmony in the Round

For most of Harmony Library's existence—Harmony opened in 1998--- we have collaborated with FRCC to bring the public and college community free, high quality music performances each year, something in short supply on the South side of Fort Collins. On March 31, we hosted 50 Shades of Blue, a talented local blues duo, which treated an enthusiastic crowd of 65-70 to an evening of blues covers and original songs.

#### **Staffing**

As reported previously, Sarah Scobey, Nonprofit Resources Librarian, is shifting her base from Old Town to Harmony Library at the beginning of April. At the same time, Kristen Draper, Digital Literacy Librarian, will be based out of Old Town Library.

Once Sarah has made the move to Harmony she will work in the same building with her peer team members, Molly Thompson and Anne Macdonald. Together the three comprise a team that works to serve our related target audiences of nonprofit organizations, job and career seekers, and local businesses and business people. Working together in close proximity will allow the three to function more efficiently as a team.

Kristen, as Digital Literacy Librarian, will continue in her current position. She will continue to coordinate Media Mentors and our Library District's digital literacy training for public and staff. Based out of Old Town, Kristen will be better positioned to create digital learning opportunities for our Old Town Library user community. Her Old Town location will also allow her to more readily explore cooperative opportunities with downtown partner organizations and offer new and expanded digital literacy opportunities in the Old Town Library.

### **OLD TOWN LIBRARY HIGHLIGHTS**

#### **Places and Partners**

The Old Town Library hosted the Annual Seed Swap and Giveaway, a collaborative community seed exchange and seed-starting event, presented by The Growing Project, Home Grown Food and The Fort Collins Nursery. The Growing Project is a nonprofit that promotes the value of strong, diverse and just local food system to all residents of Northern Colorado. Over 580 people lined up and wormed their way through our community room, which was packed with seeds and gardeners blooming with excited anticipation for the forthcoming fruits of their labor. The event included a cornucopia of seeds, free gardening classes, crafts and master gardeners sharing their expertise. The library is excited to cultivate this community partnership in order to build a strong, well-fed community. Thanks to Erin K., Paula, Thuan, Laura and Katie for working with these groups to present a great community event.

#### Safe, welcoming and comfortable facility

The Scope of Services for the G4S security contract renewal was updated to include guidance for the guards on specific Procedures for Daily Service. This new section in the contract provides specific guidance for how guards will approach patrons, conduct patrols, communicate with library staff and train new guards. The renewal contract also includes a shift from Upgraded Security Officers (USO) to more highly trained Custom Protection Officers (CPO). One of our goals for this shift is to reduce the number of patron behavior issues at the library by having an experienced, highly-trained security presence that can work consistently with our patrons to become responsible library users. The CPO guards usually have less staff turnover and more experience. OTL staff will work with the new guards to develop a community-building approach when resolving behavior issues while setting clear expectations for acceptable library behavior. Another goal for the CPO model is to reduce the amount of time library employees are spending on behavior issues.

The new security cameras are installed and activated. Eileen is working with David and Ken to finalize staff procedures that align with the Security Camera policy.

#### **Staff Activities and Programs**
